- What should NZ taxonomy Purpose Statement be taking into consideration:
 - o Paris Agreement
 - Key national policies
 - o Environmental priorities

- Implications of alignment with Australia and EU.
- Indigenous values, indigenous peoples and treatment in taxonomies globally
- Focus to be on the outcomes we want in terms of decarbonisation and nature.
- Defining which activities are green and identifying measurable metrics.
- Mandatory compared to voluntary what drives change?

CBI to propose a Purpose Statement for consideration.

- What are the differences in international approaches and needs to Aotearoa NZ.
- Reminder of what a taxonomy is and what elements if needs to accommodate and prioritize.
- Common underlying features noted.
- Guiding Principles of Australia outlined.
- Needs of NZ proposed by CBI for discussion:



- 1. Science-based and activity specific
- 2. Credibility
- 3. Usability
- 4. Interoperability
- 5. What else?

Discussion, questions, thoughts shared on variety of points including:

- Science-based not being an appropriate term as a principle. Details provided on why science-based was included.
- Need to incorporate indigenous contribution.
- How to incorporate measurable values, criteria.

Outline of Free, Prior, Informed (FPIC) consent definition provided to the meeting. Discussion and examples outlined.

Environmental Objectives of the Taxonomy for NZ

Points to be considered identified as:

- What are final objectives for NZ? E.g., options to prioritise mitigation, adaptation and biodiversity.
- Will the taxonomy be aligned to international commitments such as Paris Agreement and the Global Biodiversity Framework?
- Are there any unique objectives for NZ to include?

Recap of Principles and Objectives spoken to

- Substantial contribution
- Do no significant harm
- Social safeguards

Environmental Objectives of EU and Australia presented - including circular economy. Environmental Objectives across various taxonomies presented.

Planetary Boundaries presented and these were shown plotted against global frameworks.

Review of Adaptation and Resilience from last meeting with discussion and outline of the work being done to define this.

Proposed core environmental objectives presented by CBI for discussion:

- 1. Climate mitigation
- 2. Climate change adaptation
- 3. Pollution prevention and control
- 4. Biodiversity and ecosystem protection
- 5. Sustainable use and protection of water resources
- 6. Circular economy.

Discussion on how to adapt for NZ.

Questions and discussion on variety of points including:

- Blending of indigenous knowledge
- Soil not being an item on its own



- Undoing legacy of past harms
- Do we expand the scope to include a social taxonomy?
